

NOTICE INVITING TENDER FOR RUNNING OF STAFF/VISITORS CANTEEN

Sealed tenders for and on behalf of the Governor of Jammu & Kashmir affixed with revenue stamp worth Rs. 6/- are invited under two bid system (in separate covers) from reputed and experienced firm/registered company/reputed organisation/reputed agencies fulfilling eligibility criteria as mentioned in the tender form for running of staff/visitors canteen in the premises of District Hospital Kargil on contract basis for a period of two years which is extendable for another year on mutual consent and, satisfactory performance. 
