Whereas it appears to the appropriate Government that a total of **(00) Kanal (08) Marla** land is required in the **Kargil Village Kargil Tehsil Kargil District** for public purpose, namely **Construction of Link Road Kako Shilikchey under beautification of Kargil Town languishing Phase-II**. Social Impact Assessment Study was carried out by Social Impact Assessment (SIA) Unit and a report submitted / preliminary investigation was conducted by a team constituted by Collector as laid down under rule 4. The Summary of the Social Impact Assessment Report / Preliminary investigation is as follows (attach copy of SIA report):

1. The work was approved under languishing for providing road from upper Kako Shilikchay area having no road connectivity. The above road shall benefit the unconnected areas hamlet and also connecting road to school also to the proposed site for construction of ZEO Office. Further, the alignment passes through few private land belongs to nearby residents and some trees/structures were felt necessary to be dismantled by compensating the owners. The said road has benefited around more than 25 households in the hamlet making their daily life easier and overall socio economic development of the area.
2. A total number of 01 family are likely to be affected by the proposed acquisition.
3. 00 Kanal and 08 Marla of private land is likely to be affected by the proposed acquisition.
4. The extent of land proposed for acquisition is the absolute bare-minimum extent needed for the project.
5. There is no alternate place which could be proposed for the construction of link road Kako-Shilikchay.

Therefore, it is notified that for the above said project in the **Kargil Village of Kargil Tehsil Kargil District** a piece of land measuring, **(00) Kanal (08) Marla** of standard measurement, whose detail description is as following, is under acquisition:-

This notification is made under the provisions of section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), to all whom it may concern.

A plan of the land may be inspected in the office of the Collector on any working day during the working hours.

The Government is pleased to authorise Tehsildar, Kargil and his field staff to enter upon and survey land, take levels of any land, dig or bore into the sub-soil and do all other acts required for the proper execution of their work as provided and specified in section 12 of the said Act.

Under Section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase, etc., or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector.

Objections to the acquisition, if any, may be filed by the person interested within 60 (Sixty days) from the date of publication of this notification as provided under section 15 of the Act before Collector.
