

**OFFICE OF THE DISTRICT MAGISTRATE, YAMUNA NAGAR.**

**ORDER**

Whereas, Civil Surgeon, Yamuna Nagar has intimated that District Yamuna Nagar has witnessed sharp rise in the COVID-19 cases in the month of April 2021 and that more than 5000 cases have been reported in this month. The exponential rise has led to shortage of beds especially of critical care beds in COVID hospitals. There is likelihood of demand of more hospitalization in the district. Effective health services and ensuring its efficient management is of utmost priority of the District Administration. Therefore, it has been decided to reserve sufficient number of beds at designated private hospitals for COVID patients.

Therefore, keeping in view the current situation of surge in COVID-19 cases, I, Mukul Kumar, IAS, District Magistrate-cum-Chairman District Disaster Management Authority, Yamuna Nagar, in exercise of powers conferred upon me under section 33 and 34 (a), h(i) of The Disaster Management Act, 2005, do hereby direct all public/private hospitals to ensure that at least 50% of total beds capacity of general category and 70% of total bed capacity of ICU/Ventilator category of all Public/Private Hospitals in Yamuna Nagar are to be dedicated for COVID-19 cases with adequate availability of human resources and logistics (Drugs, Consumables, ICU etc.). In case of an urgent need to divert the beds, any change in the above reservation/requisition can only be made with prior approval of the District Magistrate, Yamuna Nagar and Civil Surgeon, Yamuna Nagar.
