


ORDER

Whereas, vide order no. 448/DDMA/COVID-19 dated 22-08-2021 the District Disaster Management Authority, Yamuna Nagar extended the "महामारी अलर्ट सुरक्षित हरियाणा" (Mahamari Alert-Surakshit Haryana) for a fortnight i.e., from 23.08.2021 (05:00 AM onwards) to 06.09.2021 (Till 05:00 AM) in the District Yamuna Nagar alongwith guidelines to be implemented (during this period) .

In compliance of the order no DMC-SPO-2020/9639 dated 28/08/2021 of Chief Secretary-cum-Chairperson Haryana State Executive Committee . Now after duly Considering the fact although the COVID- 19 positivity rate and the number of new COVID- 19 positive cases have declined, so as to the preventive and the precautionary measures to contain the COVID- 19 pandemic, in exercise of power conferred under section 30 and 34 of the Disaster Management Act, 2005, I, Girish Arora, IAS, District Magistrate-Cum-Chairperson, District Disaster Management Authority, Yamuna Nagar hereby direct that the Anganwadi Centers and Creches run by Women and Child Development Department shall remain closed in the District upto 30.09.2021.

ORDER
