2. The interested quotationer /owner of commercial vehicle shall have to submit rate in the plain paper addressed to the District Panchayat Officer ,Gomati District, Udaipur attaching of agreement letter of all point of Terms and Condition mentioned as under.

3. Required for submitting the one year valid documents 1. Meant for manual of manufacturing 2. Road Tax clearance 3. Valid road permit 4. Insurance clearance 5. Pollution certificate 6. Registration of Ownership 7. Professional Tax clearance 8. Valid commercial driving Licence.
4. The tender shall have to be accepted within the limited of Govt approved rate of DFPRT Rules-2019 which states per kilometre @Rs-11/- and detention charge for 24 hours is Rs,1200/- per day, but the lowest rate quoted by the bidder will be accepted.
