**NOTICE INVITING TENDER**

On behalf of the Governor of Tripura, sealed tender is hereby invited by the undersigned from the **CAG empanelled Chartered Accountant (CA)/CA Firm** for Auditing of PMAY(G) Accounts for the financial year 2020-21 of Gomati District. Bidders should quote the rate both in figures & words in plain paper and submit required documents along with the tender. Any incomplete bid should summarily be rejected. The firm shall not be blacklisted by any government department /agency.

Tender should only be dropped in the specific tender box kept in the office chamber of the Senior Deputy Magistrate (HoO/DDO), DM's office, Gomati District, Udaipur on or before 07-06-2021 (the 7<sup>th</sup> June, 2021) at 11.00 AM and the same will be opened on the same day at 11.30 AM, if possible in presence of the tenderer or his/ her representatives, if remain present. If last day of receiving tender or the day tender opening becomes paralysed due to any un-foreseen reason(s)/holiday then the next government working day will be the last day of receiving tender or the day of tender opening.

The rate of minimum fee for auditing of the housing account (IAY, PTG, PMAY-G & PMAY-G Administrative for the FY 2020-21) is Rs.10,000/- (Rupees- Ten thousand) only.

3. The firm shall submit a certificate stating that it has not been blacklisted by any government department / agency.
4. The Audit Report comprising 3 (three) sets shall have to be delivered within 05 (five) days from the date of completion of Audit else penalty of 1% on contract amount per day for delay will be imposed.
5. Rate should be quoted distinctly both in figures and word separately including all taxes and it cannot be changed after dropping the tender. No overwriting or erasing will be allowed.
6. No advance payment shall be made.
7. GST Registration (Permanent/Provisional) certificate, PAN card are mandatory for dropping the tender,(Self attested photocopy to be enclosed along with the tender & original when asked for after opening the tender). Tender without these enclosure will be rejected.
8. The sealed quotation to be dropped in the office chamber of the Sr. Dy. Magistrate, D.M.'s office, Gomati District, Udaipur up to 11.00 A.M. of 07-06-2021.
