On behalf of the Governor of Tripura, the undersigned invites sealed rate quotation in plain paper, in pursuance of the Memorandum issued by the Revenue Department, Govt. of Tripura, vide No.F.12(5)-REV/COVID-19/2021, Dated: 02.06.2021; for- Vehicles to be utilised for carrying of dry ration Commodities/Consignment from the MARKFED Central Go-Down, Badarghat, Agartala, West Tripura to the respective Bhagini Nivedita Girls HS school under UDAIPUR Sub Division, GOMATI District and includes cost of adequate labours for loading the commodities into the Vehicle at MARKFED, Central Godown and unloading of commodities at Respective school from Bonafide experienced Indian nationals and habitant of Udaipur Sub-Division who are Registered Firms/Co-operative Societies/Public sector undertaking/Transport Syndicates/Transport Contractors having adequate resources for carrying/ transportation works and having relevant experience in such kind of services to Govt. Offices as per following terms and conditions of the quotation, to be dropped in the tender box in the SDM office, Udaipur, Gomati Tripura upto 09.06.2021 at 3.30 PM.

Special care should be taken that No commodities/edibles or packing bags, should be damaged during the transit period. Also, that No quantity of Edibles/commodities are misplaced/lost during transportation failing which, the Bidder awarded the works shall be liable to pay the monetary value of the items lost/damaged or replacement, as deemed fit by the competent authority.

The Tender Box will be kept open for dropping of Tender by the intending parties in the office chamber of the undersigned from 07.06.2021, 11:00 AM to 09.06.2021, 4:00 PM except government Holidays and the box shall be opened on the last day at 09.06.2021, 3.30 PM, if possible in the presence of Bidders/Tenderer who have participated in the quotation. If for any unforeseen reason tender box cannot be opened in the last day, it will be opened in the next working day.
