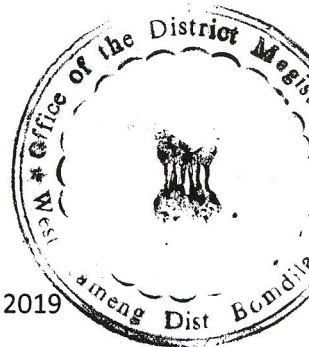

**ORDER**


WHEREAS, Election Commission of India has announced the schedule for General Election to Lok Sabha and Legislative Assembly Arunachal Pradesh 2019 Vide Letter NO. ECI/PN/23/2019 dated 10<sup>th</sup> March 2019 and Model Code of Conduct is in force.

AND WHEREAS, it has been brought to my notice that the road closure of B-C-T Road from Bhalukpong to Bomdila is impeding movement of all Election related Magistrate, officers and personnel and also obstructing other Election activities/training.

Therefore in view of all of the above, I Dr. Sonal Swaroop, IAS, District Magistrate cum District Election Officer, West Kameng district hereby revokes the order U/S 133 Cr.P.C Vide order NO. BJ-1714/17-18 dated 12.08.2018 and CO 14 BRTF is directed to comply with following orders:-

- 1) 14 BRTF CO and both the OCs of 91 and 127 RCC shall ensure that B-C-T road is kept open round the clock (for 24 hours, all 7 days in week) till 15th April, 2019 mandatorily.
- 2) Sufficient excavators and manpower to be placed at all vulnerable sites to clear the muck so as not to let any landslide/muck block the road thereby hampering vehicular movement.

Any violation of this order shall be construed as obstruction to election works and dealt accordingly.


