## **Notice**

The Legal Advisor-cum-Joint Secretary, Law and Judiciary Department, Mantralaya Mumbai vide his D.O. Lettaer No.Misc-2016/p.k.217/ka-14 Dt.-14/2/2017 has invited application in prescribed forms from eligible candidates for appointment **to the post of Special Public Prosecutor, under the Commission for Protection of Child Right Act, 2005 (4 of 2006)**

2. The above appointments will be purely on temporary basis and terminable at any time without assigning any reason and subject to the provisions of section 26 of the commission for Protection of Child Rights Act, 2005 (4 of 2006), section 24 (3) of the Code of Criminal Procedure, 1973 (II of 1974) and Rule 11, 12, & 13 of the Maharashtra Law Officers (Appointment, Conditions of Service and Remuneration) Rules, 1984

**Preference will be given to eligible woman candidates.**

3. **Eligibility for Appointment :-**

- 1) Applicant must be a Citizen of India.
- 2) Applicant must hold a degree in Law from any recognized university and be enrolled as an Advocant with the Bar Council of Maharashtra and Goa.
- 3) Applicant must not be more than 55 years of age on the date of advertisement.
- 4) Applicant must have at least 7 years of practice as an Advocate on the date of advertisement.

4. The applicants who desire to apply for the above posts may submit the application in the prescribed pro-forma annexed herewith, The applications should be addressed to the District Collector, District Gondia. The application duly filled in must be submitted to the District Collector Office, Magisterial Branch, **by hand delivery.**

5. The last date for submission of application is 21/9/2018 The applications received after the last date as well as incomplete and illegible applications will not be considered.

6. The applications must be accompanied by attested photocopies of documents/testimonials, with regard to eligibility criteria as mentioned in Para 3.

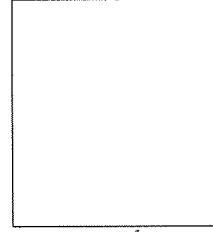
