He/ She will have to produce the following certificates:-

1. Medical Fitness Certificate from the Chief Medical Officer, Kangra at Dharamshala.
2. Certified copies of Educational qualification/age proof certificates.
3. Character certificate from the competent authority.
4. Himachali Bonafide Certificate.
5. Proof of not holding any post/office of profit.
6. The concerned candidate shall furnish a declaration to the effect that he/she is not a dismissed employee of any Govt/Semi Govt. Department / Organization.
7. The appointment may be terminated at any time by serving a month's notice on either side without assigning any reason .
8. The concerned candidate will have to make an oath of allegiance/faithfulness to the constitution of India.
9. In case a candidate belongs to Antodaya/IRDP family he/she shall have to produce the certificate to this effect from Block Development Office of the area concerned.
10. In case any of the certificates/Information produced/given by the candidate is found false/wrong, his/her service will be terminated.
11. He/She will be appointed as Part-Time Worker for four hours per day and will be paid wages at the above rates as prescribed by the Revenue Department Himachal Pradesh Govt. or its authority from time to time.
12. If the above terms and conditions are acceptable ,he/she is directed to join his duty at the place shown against his/her name alongwith requisite documents/certificates within ten days from the receipt of this order failing which offer shall stand automatically cancelled.


