Desirable Qualifications:

Knowledge of customs, manners and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.

Age: Age of the candidate should be between 18 years and 45 years as on 01.03.2020. The upper age limit is relax-able for Scheduled Castes/Scheduled Tribes/Other categories of persons to the extent permissible under the general or special order(s) of the Himachal Pradesh Government.

The application must reach in this office of Chairman, H.P. State Waqf Tribunal, Kangra at Dharamshala on or before **14.03.2020**, however, the last date submission of applications for the candidates belonging to the tribal areas in Himachal Pradesh will be **24.03.2020**. Each envelope should contain application of one candidate only. However, candidates are required to produce original certificates at the time of interview.

1. The daily wages shall be paid at the rate of @ 250/- per day and revised from time by the State Government.


2. The candidate shall not be involved in any criminal case and no criminal proceeding shall be pending or contemplated against him/her.

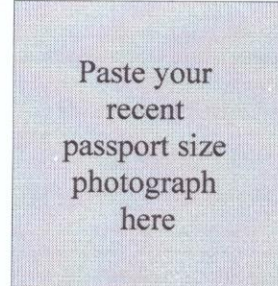
