ORDER UNDER THE DISASTER MANAGEMENT ACT 2005

WHEREAS by order no. 438-58 SK/ DM dated 23.03.2020, Shree Balaji Hospital, Kangra and adjoining Sood Sarai/ Bhawan were declared as Institutional Quarantine Facility (IQF) and placed under the control and at the disposal of the Chief Medical Officer (CMO), Kangra for the purpose of isolating persons who had been exposed to COVID-19 in order to contain the community transmission of the deadly disease;


WHEREAS by letter no. 988 dated 30.03.2020, the CMO Kangra has intimated that all the inmates placed in these facilities have been dealt with as per standard protocols and have been evacuated from these facilities and at present there is no inmate housed in any of these facilities who requires quarantine and therefore these facilities be de-notified and handed back to their respective in-charges;

THEREFORE, in exercise of the powers vested in me under Sections 33 and 34 of the Disaster Management Act 2005 and on the specific request of CMO Kangra, I, Rakesh Kumar Prajapati, District Magistrate, Kangra at Dharamshala, do hereby order and direct that Shree Balaji Hospital, Kangra and adjoining Sood Sarai/ Bhawan shall not constitute an IQF henceforth and their whole campus including all assets therein shall be handed over by CMO Kangra to the respective in-charges/ management after ensuring that the facilities are fully sanitized as per standard protocols of Government of India to prevent the transmission of COVID-19;

Any obstruction, resistance or refusal by any officer, official or any other person to comply with the directions as aforesaid shall render such person liable to prosecution under Sections 269, 270 of IPC, 1860 and Sections 51 and 55 of the Disaster Management Act 2005;

THIS order shall come into effect immediately and shall remain valid until further orders;
