WHEREAS it has been brought to the notice of the undersigned by the Health Department that a positive case of COVID-19 has been found in Ward No. 1 of Gram Panchayat Kulthi, Development Block Kangra in Sub-Division Kangra of District Kangra on 12.05.2020 which may become a probable hotspot of COVID-19 unless strict measures are taken urgently for geographic quarantine of the concerned area;

WHEREAS it is a case of extreme emergency and the circumstances are such that serving of notice upon all persons residing in the jurisdiction of the areas mentioned below is not practicable and possible and therefore, it is necessary and expedient to proceed ex-parte under Section 144 of the Code of Criminal Procedure, 1973;

WHEREAS by order no. 3192-3204 dated 11.05.2020, area of Ward No. 6 of Gram Panchayat Kulthi has already been sealed and area of Ward No. 7 is contiguous to both Ward No. 6 and Ward No. 1 of Gram Panchayat Kulthi;

THEREFORE, in view of the above circumstances and as an emergency containment measure, I, Rakesh Kumar Prajapati (IAS), District Magistrate, Kangra (Himachal Pradesh), in exercise of the powers vested in me under Section 144 of the Code of Criminal Procedure, 1973, do hereby order and direct the COMPLETE SEALING OF THE AREA OF THE CONTAINMENT ZONE SHOWN BELOW:

Kangra	Ward No. 1, 6 and 7 Gram Panchayat Kulthi	Remaining area of Gram Panchayat Kulthi

It is further ordered that:

- (i) Clear entry and exit points shall be established for stringent perimeter control of the Containment Zone by SDM Kangra and DSP Kangra with immediate effect.

- (ii) Under NO CIRCUMSTANCES SHALL THERE BE ANY INGRESS/OUTGRESS OF ANY PERSON OR VEHICLE from the Containment Zone at any time of the day except for persons/ vehicle involved in enforcement of containment plan and maintaining essential services including medical emergencies.
- (iii) Details of all persons (name, address and mobile numbers) moving out of the perimeter of the Containment Zone for essential/ emergency services will be recorded by DSP Kangra, as the case may be, and they will be followed up through IDSP by CMO Kangra.
- (iv) Thermal screening shall be carried out at all entry and exit points by CMO Kangra.
- (v) All vehicles moving out of the perimeter control will be decontaminated with sodium hypochlorite (1%) solution. Services of MC Kangra and GP Kulthi may be requisitioned by the SDM Kangra for this purpose and relevant expenditure shall be borne by the local body concerned.
- (vi) Every person residing within or entering the Containment Zone shall wear a face-cover/mask.
- (vii) No person shall leave their home on foot or through vehicle or travel or move around, roam around or stand or be found on any public path or place in the aforementioned Containment Zone, except for medical emergencies with the specific permission of SDM Kangra. There shall be no curfew relaxation hours in respect of the Containment Zone.
- (viii) Supplies of essential items in the Containment Zone shall be done through home delivery by SDM Kangra and DSP Kangra.
- (ix) All the relaxations given vide orders no. 1675-1700 SK/DM dated 20 April, 2020, no. 1860-1900 SK/DM dated 25 April, 2020 and no. 2064-74 SK/DM dated 04.05.2020 are hereby withdrawn in respect of the Containment Zone mentioned

above. No public or private works or activities shall be carried out in the Containment Zone and no offices located within the Containment Zone shall be opened.

- (x) All residents of Containment Zone shall download, install and use Aarogya Setu app. Pradhan and Panchayat Secretary/ Sahayak of GP Kulthi shall ensure 100% coverage of Aarogya Setu app.
- (xi) CMO Kangra shall ensure implementation of all protocols prescribed by the Health Department in respect of the Containment Zone and the Buffer Zone.
- (xii) CMO Kangra shall obtain a list of all fresh arrivals from outside the District in the Containment and Buffer Zones from In-charge District Control Room/ SDM Kangra and they shall be particularly and actively followed up by the Health Department.

This order shall come in to effect immediately and shall remain in force till May 24, 2020.

Any person contravening this order shall be liable for prosecution under Sections 269, 270 and 188 of IPC 1860;
