ORDER UNDER SECTION 34 OF THE DISASTER MANAGEMENT ACT-2005

WHEREAS, the recent reports of Covid positive patients in district Kangra reveals that there is 104.8% growth in Covid positive patients in last one week and there is a dire need to curtail the transmission chain of Covid-19 in the early stage;


WHEREAS, it is proven and evident scientific fact that Covid- 19 vaccination if administered along with adherence to Covid safety protocol such as social distancing and wearing of face mask etc. could be the most effective strategy to curtail the transmission of Coronavirus;

WHEREAS, in order to mitigate the third wave of Covid-19 and to ensure the health and safety of public at large in District Kangra, it is necessary to vaccinate maximum population of the District;

WHEREAS, I am of the view that there is profound requirement to cover maximum population of the District for Covid-19 vaccination at the earliest and there is sufficient ground under section 34 of the Disaster Management Act-2005 to issue stringent directions to all stakeholders to gear up the vaccination drive in this District;

THEREFORE, I, Dr. Nipun Jindal, District Magistrate, Kangra at Dharamshala, in exercise of the powers conferred in me under Section 34 of the Disaster Management Act-2005, and in welfare of public at large, do hereby order and direct that a Mass Covid-19 Vaccination Drive shall be organized in District Kangra from 11th August, 2021 to 14th August, 2021 for vaccination of all those residents of District Kangra who have not got vaccinated with first dose of Covid-19 vaccination and in this regard:


- I. a Mass Registration Campaign shall be organized at Gram Panchayat Level on 11th August, 2021 by District Panchayat Officer, Kangra in coordination with concerned Sub Divisional Magistrates and Block Medical Officers for all those who have not got vaccinated with first dose of Covid-19 vaccination;
- II. arrangements for registration regarding to Covid-19 vaccination during the above said drive shall be ensured at Panchayat Ghar and all Covid-19 safety protocol shall be ensured;
- III. Superintendent of Police, Kangra shall ensure maintenance of Law and Order at the registration site;
- IV. all Block Medical Officers shall ensure Covid-19 vaccination of all registered persons on or before 14th August, 2021 in coordination with concerned Sub Divisional Magistrates and if additional human resource required in this regard, may send requirement to Education Department through concerned Sub Divisional Magistrates;



- V. Deputy Director, Higher Education and Deputy Director Elementary Education in District Kangra shall ensure to deploy necessary staff as requisitioned by Sub Divisional Magistrates.

COMPLIANCE to this order shall be ensured by Superintendent of Police Kangra, all Sub Divisional Magistrates, Chief Medical Officer, District Panchayat Officer, Block Medical Officers, Block Development Officers, Deputy Director Higher, Education and Deputy Director, Elementary Education, Members of PRIs and ULBs in District Kangra. Any obstruction, resistance or refusal by any officer, official or any other person to comply with the directions as aforesaid shall render such person liable to prosecution under sections 51 to 60 of Disaster Management Act, 2005.


