## ORDER UNDER SECTION 34 OF THE DISASTER MANAGEMENT ACT 2005

In compliance to order no Rev(DMC) (C) 20-2/2020-COVID-19 dated 8<sup>th</sup> November, 2021, issued by the worthy Chief Secretary-cum-Chairperson, State Executive Committee, Himachal Pradesh, I, Dr. Nipun Jindal, IAS, District Magistrate, Kangra at Dharamshala in exercise of the powers conferred in me under Section 34 of the Disaster Management Act, 2005, do hereby order and direct that:

1. No Mask-No Service policy will remain operational in the District.
2. Education Department is now allowed to open Schools from Class 3<sup>rd</sup> onwards w.e.f 10.11.2021. For Class 1<sup>st</sup> & 2<sup>nd</sup>, schools will be allowed to open w.e.f. 15.11.2021. Education Department shall adhere to the safety guidelines and SOPs for COVID-19 appropriate behavior and protocols.
3. In indoor/ covered areas and open spaces, for all social/ academic/ sports/ entertainment/ cultural/ political/ religious and other congregations are allowed with 50% of the capacity subject to the adherence of the COVID-19 safety protocols and COVID appropriate behavior.


### Penal Provisions:

Any person violating these measures and not following COVID appropriate behavior will be liable to be proceeded against as per the provision of Section 51-60 of the Disaster Management Act, 2005, besides entailing legal action under Section 188 of the IPC and other legal provisions as applicable.

This order will come into effect immediately as per above mentioned dates in the district and shall remain in force till further order.

This order will supersede all previous orders.


