Water Purifier with R.O & U.V , 5. Printer, 6. Online UPS (10 KVA), 7. High Speed Scanner, 8. Printer with Xerox facility, 9. Wall Mount Monitor Stand, 10. Scanner, 11. Cartridge for Printer ” to MKCG Medical College Hospital, Berhampur. are to be submitted by Regd. Post/ Speed Post/ courier and reach in the office of the Superintendent, M.K.C.G Medical College Hospital , Berhampur – 4 on or before **30.04.2018** by **5:00 p.m.** The tenders received beyond the scheduled date and time will not be entertained under any circumstances. The tenders are of double bid system i.e. 1) Technical Bid & 2) Price Bid. The intending tenders should submit their tenders separately in two sealed covers duly super scribed as Technical Bid & Price Bid putting in a single sealed cover. The tenders should furnish the Earnest Money Deposit Of Rs. 10,000/- (Ten thousand)(refundable) only in shape of Bank Draft in favour of the Superintendent, M.K.C.G Medical College Hospital, Berhampur payable at SBI, M.C.C. Branch, Berhampur. The EMD will be forfeited in case, the successful tenders fails to execute the order within the stipulated period.
2. The sealed tenders (Technical Bid) shall be opened by the Tender Committee on 03.05.2018 in presence of either the tenders or / their authorized representatives. If any tender or/ their authorized representatives fails to turn up at the time of opening of the tenders, the process will continue as usual.
3. All tenderers should give live demonstration of the equipment before the Technical Experts if required.
4. After finalization of the technical bids by the Technical Bid Committee, the price bid of the successful firms who qualify in the technical specification will be opened by the Price Bid Committee on another date as fixed by Superintendent.
5. The tender should be clearly written/ typed without any corrections, interpolation and over-writings etc and each page of the tender should bear the dated signature of the tenders.
