**ORDER**

Keeping in view of the gravity of the resurgence due to COVID-19 pandemic and as preventive measures in the interest of the general health of public and preventing spread of infection & consequent upon order No. 2380/ R&DM(DM) Dated 04.05.2021 of SRC, Odisha, Bhubanswar, it is ordered that:

1. The GM, DIC shall act as Nodal Officer of Border Check Point( BCP) located at Girisola. The brief assignment is as follows
  - a. Anyone coming to Odisha from Andhra Pradesh and Telengana by personal/hired vehicles(two-, three- or four-wheelers)/ trains or entering the state in any other mode shall undergo **manadatory institutional quarantine for 14 days in cluster TMC** i.e Biju Patnaik Adarsh Vidyalaya, Konisi.
  - b. The exclusion criteria in the aforesaid guideline shall be strictly adhered to.
2. DWO, Ganjam will act as Nodal Officer of aforesaid Cluster TMC and shall work in coordination with GM, DIC, Ganjam.He is ordered to ensure the campus is ready in all respect i.e Electricity, Light, Toilet,Water,Fan etc. for receiving the persons in close coordination with BDO, Rangeilunda and Sub-Collector, Berhampur-cum-District COVID Nodal Officer.
3. Regional Transport Officer, Ganjam with the help of District Police and under active guidance of Distict Collector will set up Border Check Points (BCPs) with reference to direction given by SRC, Odisha and maintain a Regsiter in this context as done earlier in Phase-I of COVID-19

In view of the above directives, it is also ordered to operationalize a Border Check Point (BCP) at Girisola immediately with the following operating procedure under direct supervision of Sub-Collector-cum- District COVID Nodal Officer, Berhampur.

- a. The Superintendent of Police, Berhampur is requested to deploy police personnel at stragic locations i.e Giriosola Border Check Point (BCP).
- b. Regional Tranport Officer, (RTO), Ganjam ,Chatrapur is directed to deploy their supporting staff to check the vehicles at BCP by issuing an Official order.
- c. The GM, DIC, Ganjam is instructed to supervise the overall activities in coordination with SP, Berhampur, RTO, Ganjam & DWO, Ganjam.

Any person found violating the guidelines issued by the Govt. order No. 2380/ R&DM(DM) Dated 04.05.2021 of SRC, Odisha, Bhubanswar shall be punished under the supervision of the Disaster Management Act,2005 and other relevant laws.
