OFFICE ORDER

Whereas, the Government of Odisha vide Revenue & Disaster Management (Disaster Management) Department Notification No. 1663/R&DM (DM) Dtd.31.03.2021 has declared SARS COV-2 as a "DISASTER" under Section 2 (d) of Disaster Management Act, 2005 for the State of Odisha and promulgated Odisha COVID-19 Regulation, 2020 by virtue of the power conferred under section 2, 3 and 4 of Epidemic Disease Act, 1897 for containment of COVID-19.

And whereas, Government of Odisha has issued various measures to contain the spread of COVID-19 vide order No. 3856/R&DM (DM) dated.30.06.2020.


And whereas, Five persons found COVID positive cases have been reported from **village Sana Baragan (House of Laxmi Gouda, Lili Gouda, Jhunu Sahu, Panchu Behera & Ruma Behera), Nimina GP under Polasara Block**, It is therefore necessary to contain the area for effective containment with surrounding buffer Zone for monitoring of COVID related preventive measures.

Now therefore, in larger public interest and with a view to contain to spread of COVID19, I **Sri Priyaranjan Prusty, OAS (SB), Sub-Collector & Sub- Divisional Magistrate, Chatrapur, Ganjam** being the Empowered Officer designated under the Odisha COVID 19 Regulation 2020, do hereby order the following.

1. The area coming within the boundary as indicated below is hereby declared as (Map enclosed) Containment Zone covering following area:
(Village Sana Baragan (House of Laxmi Gouda, Lili Gouda, Jhunu Sahu, Panchu Behera & Ruma Behera), Nimina GP under Polasara Block)
2. The area mentioned above of Polasara Block is hereby declared as CONTAINMENT ZONE. The boundaries of Containment Zone are as per the Trace map attached herewith. The movement of people inside the Containment Zone and to and fro from the Containment Zone is strictly prohibited.
3. The rest area of village Sana Baragan surrounding the Containment Zone are hereby declared as BUFFER ZONE and the boundaries of Buffer Zone are as per the trace map attached. The movement of people in Buffer Zone is allowed only for emergency services.
4. The IIC, Polasara P.S. is directed to create a temporary check post at the entry point of **village Sana Baragan (House of Laxmi Gouda, Lili Gouda, Jhunu Sahu, Panchu Behera & Ruma Behera), Nimina GP under Polasara Block** and to regulate the entry and exit from the Containment Zone.
5. The Superintendent of Police, Ganjam is requested to provide adequate manpower and logistic support for the check posts at the marked point.
6. Sri Dilip Kumar Nayak, Tahasildar, Polasara is hereby deployed as Executive Magistrate and overall In-Charge of Containment Zone and Buffer Zone.
7. All vehicular movement, movement of public transport and personnel movement will be stopped barring extremely urgent medical cases with the permission of undersigned.
8. All inhabitants within the Containment and Buffer Zone shall strictly remain in home. All the shopping establishments whatsoever nature shall be closed immediately. The supply of essential and medical requirements will be ensured through various teams under the Block Development Officer, Polasara.
9. All the Government and Private institutions located within the boundary of Containment Zone and Buffer Zone are hereby closed herewith.
10. The MO, CHC, Polasara is directed to complete house to house screening & Swab collection of active contacts and shifting of positive patients immediately. Intensive Surveillance mechanism as outlines in the Standard Operating Protocol (SOP) issued by MoHFW shall be established within the Containment Zone. The local authority shall ensure 100 % coverage of Aarogya Setu App / SWASTHYA App among the residents of Containment Zone. In the Containment Zone, following activities shall be undertaken by the local authorities.


- a. Contact Tracing.
 - b. Home Institutional Quarantining of individuals based on assessment by medical officers. This risk assessment will be based on symptoms, contact with confirmed cases and travel history.
 - c. Testing of all cases with Severe Acute Respiratory Infections (SARI), Influenza like illness (ILI) and other symptoms specified by MoHFW. House to house surveillance by special team constituted for this purpose.
 - d. Clinical management of all cases as per protocol.
 - e. Counseling and educating people and establishing effective communication strategies.
11. The BDO, Polasara is requested to barricade the entries and exit of the Containment Zone and to engage service providers for all essential services at door step of the people.
 12. The Station Officer, Fire Station, Polasara is directed to fumigate and sanitize all the areas in Containment Zone & Buffer Zone.
 13. The C.D.P.O., Polasara is requested to provide all the help to the BDO, Polasara and MO, CHC, Polasara for providing of service in connection with health screening at Containment and Buffer Zone respectively.
 14. In the Containment Zone, there shall be strict perimeter control to ensure that there is no movement of population in or out of the zone except for medical emergencies and for maintaining supply of essential goods and services. The guidelines issued in this regard by MoHFW will be strictly implemented.
 15. Activities in Containment Zone.
 - Strict perimeter control
 - Establishment of clear entry and exit points.
 - Movement of persons only for maintaining supply of goods and services and for medical emergencies.
 - No unchecked influx of people and transport.
 - Recording of details of people moving in and out of perimeter.
 16. Daily reporting is to be submitted by the SDMO & PHO, Chatrapur to the undersigned with reference to the L.No.10611/H dated.04-05-2020 of Principal Secretary to Govt., H & F.W Department, Odisha, Bhubaneswar.

The order will remain in force from today i.e. 18.05.2021 till modified or revoked by the undersigned.



Sub: Declaration of Mini Containment Zone of Village Sana Baragan under Nimina Panchayat of P.S Polasara, Polasara Block.

Sir,
I am to inform you that at present now 05 (five) persons of Sana Baragan Village House of Laxmi Gouda, Lili Gouda, Jhunu Sahu Panchu Behera and Ruma Behera have tested COVID positive and they are in Home Isolation. So there are several direct contact persons with the above positive persons for which it is necessary to declare the area as Mini Containment Zone in order to prevent further spreading.

As per the direction of PD, DRDA, Ganjam the Sana Baragan Village House of Laxmi Gouda, Lili Gouda, Jhunu Sahu, Panchu Behera and Ruma Behera may be declared a Mini Containment Zone and rest part of Sana Baragan village may also be declared as Buffer Zone. Trace map indicating Mini Containment Zone and Buffer Zone is attached herewith for your kind reference.

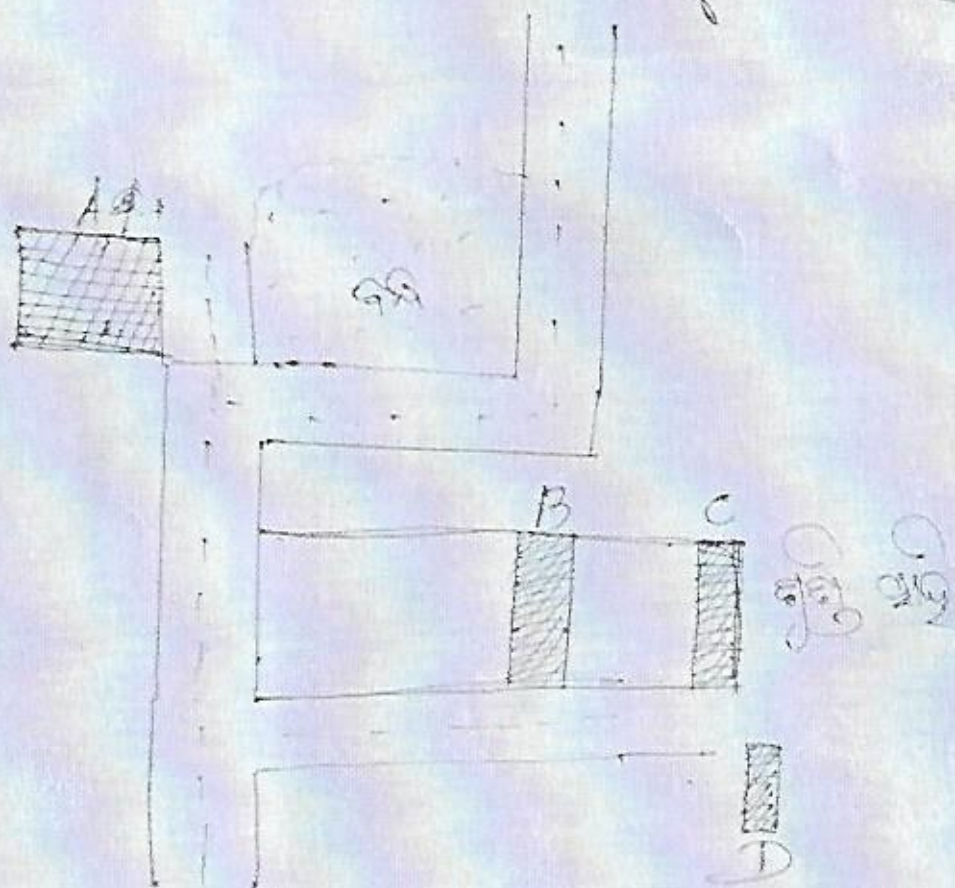
