3. The Tender is to be super scribed with the name of the work and item of the work tendered for.

4. Registered contractors of Class B & C can obtain tender documents for the work either from Office of the Panchayat Samiti, Buguda or from the official website i.e. <http://www.ganjam.nic.in> in all working days during office hours from 7.00 A.M to 1.30 P.M on payment of cost as indicated in the table shape of Cash/Ac payee DD(Non refundable) drawn in favour of Block Development Officer, Buguda.

The tender is to contain EMD as mentioned in Col.-6 in shape of N.S.C./K.V.P./Postal Savings Bank Accounts/Post Office Term Deposit Account/TDR of any Nationalized Bank duly pledged in favour of the Block Development Officer, Buguda payable at Buguda , DD including also the cost of bid document drawn in favour of Block Development Officer, Buguda payable at Buguda (if bid document downloaded from website), self attested photo copies of registration certificates, PAN card, valid GSTIN registration Certificate/Clearance certificate , undertaking/certificates duly filled, affidavit, work experience certificate, machineries available etc . Further, any extra financial liability arising out of the GST implementation by the Government shall be borne by the bidder

6. The tender shall be received in the above Office in all working days during Office hours from 31.05.2021 to 07.06.2021 except holiday. The tender shall be opened in the chamber of BDO, Buguda on 08.06.2021 at 11.30 A.M in presence of Tenderer or their authorized representative. If any of the dates will be declared as Government Holiday, then the next working day shall be considered for sale of tender papers, receipt and opening of tender paper respectively.

7. The tender shall be received in the Office of the BDO Buguda, Ganjam within the stipulated date & time and also by registered post/speed post. The Tenderer shall submit the required documents in a sealed cover super scribed with the name of Work only and it shall be ensured that the names of firms /bidders shall not be written anywhere on the sealed cover.

8. The tender received after due date and time shall not be entertained and the authority shall not be held responsible for delay, missing of tender during postal or courier transit.

9. Any bidder backs out from the Office before acceptance of the tender, the EMD along with the other deposit, deposited by him shall be forfeited.

10. Engineering contractors intending to avail the exemption facility should apply specifically their application with an affidavit and submit the same with tender documents. He should also produce original contract license at the time of

opening of tender document to make necessary entry to that effect as such facilities are limited to their participation in the tender during the financial year otherwise the tender will be rejected on the spot during opening of the tender.

11. Conditional tenders shall be out rightly rejected. The authority reserves the right to reject any or all tender without assigning any reason there off.

12. No e-mailed/fax tender shall be entertained.

13. The tender paper received without signature of the Contractor or agency will not be entertained.
