



Sealed Quotation / Tenders are hereby invited from the interested reputed Travel Agencies/ Tour operator/ private individuals for providing .1(one) numbers of A.C. diesel driven vehicles (TUV300/ Bolero/ Sumo Gold/ Eritiga) including the driver which shall confirm to the terms and conditions vide office memorandum No. 30464/F, Dt. 06-09-2019 of Govt of Odisha, Finance Department for proper monitoring of Excise Administration and strengthening enforcement activities on monthly basis .


1. The vehicles Shall be in good condition, and shall not be older than three years. Vehicle older than five years should be replaced by new vehicles by the service provider.
2. It will be ensure through service providers of hired vehicles that vehicle is kept under optimum running conditions and avoid accidents attributable to lack of maintenance/upkeep. The Hired vehicles cannot be used for any private/ commercial purpose beyond office hours or during holidays.
3. The hiring charges do not include fuel cost (Diesel) which is to be paid separately basing on actual consumption and lubricants as per existing Government norms.
4. The Driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport vehicle .
5. The driver should be well behaved , gentle and obedient in nature.
6. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants) .
7. The vehicle must achieve a fuel efficiency of 10 K M per liter.
8. The details of the make and year of manufacture of the vehicle , Registration No. mileage (Kms covered per liter) and name of Driver with driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation / tender (Annexure -II) .
9. The quotation completed in all respect should reach the undersigned on or before **25-09-2021** by **4 P M** and shall be opened on the same day at **5 P M** in presence of bidders or their authorized representative .
