Sub:- Grant of land for Cooperative Oil Mill.

Ref:- Your letter dated 2.8.1965.

Final allotment of the land required by the society can be made only by the Commissioner, Aurangabad Division, Aurangabad. However, Commissioner has agreed that the Society may be permitted to start the work on the plot applied in anticipation of formal sanction for grant of land if the Society is agreeable to pay the market value of the land to be fixed by the Town Planning Department, and if there is otherwise no objection to the grant.

2. AS you have expressed the readiness of the Society to pay the market value to be fixed as aforesaid, the Tahsildar, Georai, is being requested to take action as preceding mentioned in the present paragraph in anticipation of formal sanction of the competent authority. The site plan submitted by you with your application only mentions the area of 2 acres which is required by you but does not show the exact measurements and location of the plot. You are, therefore, requested to finalise the exact measurements (length, breadth, etc.) of the plot required by you in consultation with the Tahsildar, Georai, and submit the copies of the sketch of the plot in triplicate through the Tahsildar, Georai, to this office as early as possible. On receipt of such sketch, the Tahsildar, Georai, will arrange to tentatively demarcate the plot and report to this office.

Final demarcation of the 2 acre plot will be made by the Dist. Inspector for Land Records, Bhir, on receipt of the sketch map.

3. The grant of permission to start construction work referred in the preceding paragraph is subject to the condition that no building construction will be made within 220' and 80' from the centre of the Aurangabad-Bhir Road and the Georai-Pangri Gart track respectively.

4. Formal delivery of possession of the land will be given after the grant is sanctioned by the competent authority, and after other formalities are completed.
