As per the Hon'ble NGT order dated: 15/07/2019 in O.A.No. 710-713/2017 the following Guidelines are issued for the District Committee.

1. The District Committee shall prepare the Environmental Plan and it shall be hosted in Perambalur District public domain (through websites).
2. The District Committee shall conduct review meeting twice every month for one year.
3. The implementation of the District Environmental Plan is to be monitored by the District Committee.
4. The District Committee shall cover all the issues which have been reflected in O.A. No.606/2018.
5. The District Environmental Plan shall cover the issues relating to
 - i Solid Waste Management.
 - ii Bio Medical Waste Management.
 - iii Plastic Waste Management.
 - iv Construction and Demolition Waste (C&D)
 - v 102 Non- Attainment Cities
 - vi Polluted River Stretches.

- vii Polluted Industrial Clusters.
- viii Industrial Pollution Control
- ix Utilization of Treated Sewage
- x Sand Mining
- xi Conservation of Water Bodies.
- xii E-Waste Management

6. The District Committee shall strengthen the enforcement mechanism to District Environmental Plan and the same shall be executed at individual Municipal / Town / Village level.
7. This shall be monitored by the District Collector / Chairman of the Committee twice in a month and monthly progress report will be submitted to the Chief Secretary to Government every month for further action.
