#### **General Terms & Conditions**

1. The bidders have to submit their tenders in separate sealed covers (i.e. Cover "A"-Technical Bid & Cover "B"- Price Bid). Both the covers should be put into a third Cover "C" which must be super-scribed as "Tender for "supply of Bike Ambulance".

### 2. The Cover "A" (Technical Bid) should contain as follows:

- 1) Checklist with details of the documents enclosed in **Cover "A"** (as per **Annexure I**) with page number. The document should be **serially arranged** as per this **Annexure I** and should be securely tied and bound.
- 2) Manufacturing unit / supplier, who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt. organization, is not eligible to participate in the tender for that item during the period of blacklisting. They should submit a declaration about this by a **Notary Public**.
- 3) EMD **Rs.10, 000/-** (Rupees Ten Thousand only Refundable) in shape of Bank Draft / Bankers Cheque in favour of ZSS Non NRHM, Khordha payble at Khordha.

- 4) The specification of the Bike Ambulance should be as follows:
  - Bike should be having 160 CC Motorcycle with side carriage.
  - The side carriage should be well covered for privacy of the Mother/patient.
  - The vehicle should be fit to run in the difficult area.
- 5) List of Item (s) Quoted individually in the prescribed format (Annexure II).
- 6) Copy of organization PAN.

- 11) All the tender documents should sign by the bidders at the bottom of each page with his official seal duly affixed.
- 12) Leaflet / Technical Brochures of the products / item offered.
- 13) They should quote the rates inclusive of excise duty, insurance, packing, forwarding, freight (door delivery) and exclusive GST (if any) and should submit a self-declaration about this.
- 14) They must submit the undertaking that they will supply the stocks within thirty days after receipt of the Purchase Order from this office. In case of non-supply, the authority may allow extension for a maximum period of 02 (two) weeks (14 days) after the stipulated date of supply with a penalty of 0.5% per week, which will be deducted from the purchase order value as "Liquidated Damage".
- 15) The supplier shall have a minimum average turnover of Rs. 30 Lakh or more in the last three year financial years i.e. 2016-17, 2017-18 & 2018-19 and copy of the audited financial statement for the last three financial year i.e. 2016-17, 2017-18 & 2018-19.

#### 3. General Condition:

- 1) Eligible bidders should submit their tender documents to the CDM& PHO Khordha through **Speed Post / Registered Post / Courier** within the stipulated date & time as mentioned in the tender notice.
- 2) Any tender documents received after the due date & time will be rejected and returned to the sender unopened.
- 3) A Pre-bid meeting will be held on the stipulated date & time in the O/o CDM& PHO Khordha.

- 4) Violating the tender terms and conditions & non-supply / partially supply / supply, which is not as per technical specification, will declared as **Blacklisted** and disqualify the firm to participate in any tender of this district for a period of next 03 (three) years from the date of issue of the letter and their E.M.D. will be forfeited.
