At the outset Chairman welcomed all the participants and thereafter proceedings of tenders were started. During process, Technical Bids of following bidders in respect of following Chowgan were received;

In respect of Chowgan No-1 no bid has been received and similarly in case of Chowgan no-3 single bid has been received. Keeping in view of urgency the committee suggested to invite the bids through limited tenders which will be opened on dated ~~20~~ ^{Sunday 11:45 A.M} 21.07.2018 (Monday) at 11:30 AM. The Chairperson apprised the matter to Worthy Deputy Commissioner who approved the same, as per recommendation of chairperson. In case of Chowgan No-4 only two bids were received. As per permission of Worthy Deputy Commissioner two bids were considered to be opened in technical process.

Chowgan No. 2:- Three bids were received in response to the tender. Out of three, two tenderer were technically qualified but one tenderer was rejected on technical ground (experience/affidavit). Hence, it is not possible to open financial bids due to non-qualification of three tenderers.

Chowgan No. 4:- With the permission of worthy Deputy Commissioner, two bids were opened; out of two one bidder is rejected on technical grounds (experience/affidavit). Hence, it is not possible to open financial bids due to non-qualification of three tenderers.

Keeping in view of urgency, the committee suggested to execute the tender process in respect of Chowgan No. 2 & 4 through limited tenders alongwith Chowgan No. 1 & 3. Chairman apprised the matter to worthy Deputy Commissioner who approved the same. The meeting ended with a vote of thanks to and from the chair.
