**NOTIFICATION**

In exercise of the powers conferred upon me under clause 3(1)(d) of the HP Hoarding and Profiteering Prevention Order, 1977, I Vivek Bhatia (IAS) District Magistrate, Chamba Distt. Chamba hereby fix the maximum margin of profit, which a dealer may charge in respect of articles mentioned in appendix -1, in Chamba Distt. as under. This order shall take effect from the date of publication in official Gazette/e- Gazette of Himachal Pradesh.

**APPENDIX -II**

- The margin of profit mentioned in Appendix -1 shall be applicable on the landed cost which is computed on the following elements of expenditure actually paid by the dealer:-
  - . Purchase Price
  - . Freight
  - . Octroi, Central Tax, Local Tax etc.
  - . Loading / unloading and cartage.
- Where a dealer is doing wholesale as well as retail sale business, he shall charge only one margin of profit on one transaction. The wholesale margin shall be allowed at one stage only at one particular station.
- No wholesaler shall transfer any commodity to another wholesaler at same station.
- Every stockist and retail chemist / Druggist in Distt. Chamba shall maintain a true account of stocks of sales and purchase of Masks and Hand Sanitizers separately and shall also furnish the information / report regarding opening balance, receipt, sales and closing balance on daily basis to Distt. Controller FCS&CA Chamba ([dfsc-cha.hp@nic.in](mailto:dfsc-cha.hp@nic.in)) on the Proforma as per clause 9(a)(b) of the Order ibid prescribed below till further orders.



5. The following limits shall apply for wholesale transactions :
  - . Masks (2 ply & 3 ply surgical Masks, N 95 Masks) =1000 Nos.
  - . Hand Sanitizers=10000 ml.
6. The following limits shall apply for any individual retail transaction:
  - . Masks (2 ply & 3 ply surgical Masks, N 95 Masks) = 25 Nos.
7. No Household shall keep in possession more than 30 Masks (2 ply , 3 ply & N 95) and 200 ml of Hand Sanitizers at a time.



They are further directed to ensure that the Masks and Hand Sanitizers are available sufficiently and are sold to customers as per margin of profit by the chemists in their respective jurisdiction.
