ORDER

In order to contain the spread of COVID-19 epidemic it is required to create institutional quarantine facility in the District for quarantine of persons identified as per the prescribed guidelines of the Health Department of GoHP and GoI.




ensured at the establishments identified above and Head of the Department of the respective establishments shall provide all necessary assistance for the same to the concerned BMO.
