**ORDER**

WHEREAS, the Ministry of Home Affairs has issued detailed guidelines to contain the spread of Coronavirus (COVID-19) vide order no.40-3/2020-DM-I(A) dated 01-05-2020, wherein it has been directed that the movement of individuals, for all non-essential activities, shall strictly be prohibited between 07:00 PM to 07:00 AM.

THEREFORE, I, Vivek Bhatia, District Magistrate, Chamba in exercise of the powers vested in me under Section 144 of the Code of Criminal Procedure, 1973 do hereby order that all movement between 07:00 PM to 07:00 AM except for meeting essential requirements and for health purposes shall remain prohibited with immediate effect till further orders.

It is also ordered that the entry at the borders for people entering for non essential purposes shall also remain prohibited from 07:00 PM to 07:00 AM. All concerned Sub Divisional Magistrates are hereby ordered to make appropriate arrangements near border entry points, so that the passengers who are coming at check-posts after 07:00 PM can stay there for the night before their further movement.

Any violation or contravention of this order shall be liable for action under relevant provisions of law.
