Clarification

As per the decision taken by the Government of Himachal Pradesh, the following is clarified in continuation to the Panch-Astra Guidelines communicated vide order No. CBA-DA-32 (I)/2020 -12085-14308 dated 3<sup>rd</sup> May, 2020:

1. That all persons returning from Baddi shall also be kept at Sub-divisional Buffer Quarantine Centres established at border entry points of the District in addition to the people having inter-state movement.
2. That all persons returning from other Districts of Himachal Pradesh (having Inter-district movement) will undergo Home Quarantine instead of Panchayat Level Quarantine subject to the condition that they have the sufficient space at home for the proper compliance of home quarantine protocol, otherwise they will be shifted to the Panchayat Level Quarantine or any nearest facility available.
3. That prior information of persons being released from border check-posts being sent to panchayats for home quarantine shall be intimated to the BDO, Pradhan and Secretary concerned so that the review of the house can be done for its suitability for home quarantine and necessary IEC of the family can be carried out. The respective BDOs shall ensure that this modus operandi of visiting the house of incoming persons and their IEC is meticulously followed, without any exception.
4. That all such persons being home quarantined shall be monitored as per the Panch-Astra protocol with the assignment of a Surveillance Personnel and Supervisory Officer.

The previous directions issued in this regard shall continue to remain the same except as modified by this order.
