**ORDER**


**Whereas**, the Gram Panchayats Diur. Pichhla Diur, and Khadjota were sealed to contain the spread of COVID-19 vide order No. CBA-Peshi-M-43(23)2019-11246-11325 dated 07-05-2020 respectively issued by this office;

**Whereas**, the Sub Divisional Magistrate, Salooni District Chamba has intimated and recommended vide his/her letter No. SLN-SDM (COVID-19)-2182 dated 26<sup>th</sup> May 2020 that a survey has been conducted by the medical team & Panchastra team and there is no symptom of SARI/ILI in the people of the area, hence, recommended to relax the restrictions imposed under section 144 of the Cr.P.C on the above mentioned Panchayats of Sub-Division Salooni;

**Whereas**, no case of COVID-19 has been discovered or identified during the period of containment, even after Active Case Finding Campaign, and as informed by Chief Medical Officer Chamba, no positive case of COVID-19 has been traced. Also a period of 14 days has elapsed since the above mentioned Panchayats were sealed;

**Now therefore**, it is ordered that the aforementioned panchayats shall no longer be sealed and curfew shall now be regulated as per order No. CBA-Peshi-M-43(23)2019-172 dated 25-03-2020 and its subsequent amendments from time to time. This order shall come into force with immediate effect and will remain in force till further order;


