ORDER

Whereas, the Ministry of Home Affairs (MHA), Government of HP has issued guidelines for extending the National lockdown until 30.06.2020 vide letter No. 40-3/2020-DM-1(A) dated 31.05.2020.

Whereas, vide order No Rev (DMC) 20-2/2020-COVID-196 dated 31.05.2020, the Chief Secretary to the Government of Himachal Pradesh has ordered the extension of lock down up to 30.06.2020 and directed the district authorities to implement the orders of MHA.

Whereas, in pursuance of above referred order/notification of the Government of India and Himachal Pradesh curfew was imposed in the district Chamba vide this office order No. CBA-Peshi-MN-43(23)/2019-15996-16063 dated 02.06.2020.

Whereas, Government of Himachal Pradesh vide his order No. Rev (DMC) (C) 20-2/2020- COVID-19 dated 14.06.2020 has incorporated some amendments and additions to the guidelines issued in SOPs of above referred order of Government of Himachal Pradesh with the direction to district authorities for ensuring strict implementation of the directions of the NDMA and NEC.

Therefore, in pursuance of the Order No. Rev (DMC) (C) 20-2/2020-COVID-19 dated 14.06.2020, I, Vivek Bhatia, IAS, District Magistrate Chamba do hereby add or incorporate the following points at the point No. 5 of this office order No. CBA-Peshi-M-43(23)/2019-15996-16063 dated 02.06.2020: -


1. The persons visiting the State for bonafide purpose of trade, business, job, project, service purpose, commission agents and *arthiyas* with supporting documents and entering the state with valid permit/e-pass and not coming from high COVID-19 case load cities and other containment zones from rest of the country will also be exempted from the purview of quarantine.
2. The management, incharge or head of any NGO or any charitable organisation, which has branches in the State, and travels to the State of Himachal Pradesh in connection with its affairs or for an official meeting, for a short duration not exceeding 48 hours and don't mix with general masses, follows all social distancing and other COVID-19 prevention protocols/norms, does not organize any social/cultural or any other gathering of any sort, shall be exempt from quarantine requirement in the State.
3. All persons coming from high case load COVID-19 infected cities will be institutionally quarantined. Only for exceptional and compelling reasons such as cases of human distress, pregnancy, death in family, serious illness, persons above 65 years of age with co-morbidities and parent (s) accompanied by children below 10 years may be permitted to be home quarantined, instead of institutional quarantine,

for 14 days, subject to satisfaction of the concerned Sub-Divisional Magistrate about satisfactory arrangements being available for such Home quarantine.

4. The migrant labourers coming in the State can be sent directly to the work site of the Orchardist/Agriculturist/Contractor/Project Proponents. The labour can start working at these sites immediately subject to observing all the due precautions including social distancing/isolation and the constant monitoring for symptoms, as is being done for quarantined persons. The period of active surveillance shall however continue to be the same as per the period prescribed by the guidelines issued by the Department of Health & Family Welfare.
5. The use of Aarogya Setu app shall be mandatory in all cases.

Rest of the conditions specified in ibid order i.e. CBA-Peshi-M-43(23)/2019-15996-16063 dated 02.06.2020 shall remain the same.


