
ORDER

Whereas, relaxation in movement of people have been provided across the country after MHA in order No. 40-3/2020-DM-1(A) dated 30.05.2020 and same has been implemented in the State of Himachal Pradesh through Order No. Rev (DMC) (C) 20-2/2020-COVID-19 dated 31.05.2020.

Whereas, this has resulted in increased flow of people across the boundaries of the district and numbers of COVID-19 positive cases are expected to rise in future.

Whereas, in view of the above stated circumstances and to effectively and timely counter the threat of COVID-19 spread in areas where positive cases are found, it is necessary that authority for declaration of Containment & Buffer Zones is delegated to Sub-Divisional level.

Therefore, I Vivek Bhatia (IAS) District Magistrate Chamba, District Chamba, in exercise of powers vested in me under section 33 & 34 of the Disaster Management Act, 2005 do hereby authorize all the Sub-Divisional Magistrates within the district Chamba to declare Containment & Buffer Zones within their respective Sub-Divisions for effectively containing the spread of COVID-19 with the direction that each such order should be a reasoned order with justification. Sub-Divisional Magistrates shall ensure strict adherence to the guidelines issued vide letter No. NHMHP-IDSP/1/2020-IDSP-Section-National Health Mission-HP-Part(1)-3598 dated 01.06.2020 for declaration & operation of activities inside Containment & Buffer Zones.
