ORDER

Whereas, a large number of COVID-19 positive cases were detected in mohalla Dharog, Chamba Town recently, therefore, keeping in view the imminent danger of spread of COVID-19 in the adjoining areas/other parts of the MC Chamba, following areas falling in the territorial jurisdiction of Municipal Council Chamba were notified as "CONTAINMENT ZONE (s) vide this office's order no. CBA/SDM/READER/COVID-19/2020 dated 08.08.2020

And whereas, it has been brought in the knowledge of undersigned by the Block Medical Officer, Health Block Pukhri that no new case of COVID-19 has been detected or identified in the abovementioned areas (except mohalla Dharog) during the period of Containment even after contact tracing, sampling of primary contacts and completion of Active Case Finding Campaign. Therefore in view of the same, Containment of these areas is not required to be continued as such.

NOW THEREFORE, in view of the above narrated circumstances, I **Shivam Pratap Singh, IAS, Sub Divisional Magistrate Chamba**, Distt. Chamba, H.P. in exercise of powers vested in me do hereby modify/revise the areas of Containment Zone (s) as under;

It is further ordered that the area of ward no. 3-Chowgan, ward no. 4-Hatnala, ward no. 5 Jansali, ward no. 6-Chountra, ward no. 7-Surara, ward no. -8 Sapri, Municipal Council Chamba shall no longer be sealed (except the areas where persons have been tested positive recently) and is hereby de-notified as Containment Zone (s). All curfew relaxations notified by the District Magistrate Chamba vide his office's orders circulated from time to time shall now be applicable in this area also.

All other restrictions shall remain applicable as notified in the earlier order.

This order shall come into force with effect from 17th of August, 2020.


