ORDER

Whereas, one positive case of COVID-19 was detected in mohalla Dharog, Chamba Town on 03.08.2020, therefore, in order to contain further spread of COVID-19, areas as detailed in the table below falling in territorial jurisdiction of Municipal Council Chamba were declared/notified as Containment Zone & Buffer Zone vide this office's order no. CBA/SDM/READER/COVID-19/2020: 2371-80 dated 03.08.2020.

And whereas, it has been informed by the Block Medical Officer, Health Block Pukhri that no new case of COVID-19 has been detected or identified in the abovementioned areas during the period of Containment even after the Active Case Finding Campaign. Therefore in view of the same, Containment of this area is not required to be continued as such. Furthermore, prescribed period has also been elapsed since this area was ordered to be sealed by this office.

NOW THEREFORE, I Shivam Pratap Singh, IAS, Sub Divisional Magistrate Chamba, Distt. Chamba, H.P. in exercise of powers vested in me do hereby withdraw the order no. CBA/SDM/READER/COVID-19/2020: 2371-80 dated 03.08.2020 issued by this office earlier.


It is ordered that the area as mentioned above shall no longer be sealed and is hereby de-notified as Containment Zone. All curfew relaxations notified by the District Magistrate Chamba vide his office's orders circulated from time to time shall now be applicable in this area also.

However, these relaxations shall not be applicable for the persons who have been tested positive for COVID-19 in mohalla Dharog, Chamba Town recently. The entire residential buildings/residential complex shall remain sealed and persons residing therein (tested positive) shall remain home quarantined till further orders.

Furthermore, ward No. 2-Kasakra notified as Buffer Zone vide this office's order no. CBA/SDM/READER/COVID-19/2020 dated 15.08.2020 is hereby de-notified. This ward shall no longer be in Buffer Zone now.

This order shall come into force with effect from 20th of August, 2020.
