ORDER

Whereas, 5 (five) positive cases of COVID-19 were detected in mohalla Lower Julakari, Chamba Town, situated in the territorial jurisdiction of Municipal Council Chamba on 06.09.2020. Therefore, in order to contain further spread of COVID-19, areas as detailed in the table below were declared/notified as Containment Zone & Buffer Zone and the same were ordered to sealed vide this office's order no. CBA/SDM/READER/COVID-19/2020: 3160-71 dated 07.09.2020.

And whereas, it has been informed by the Health Department that most of the samples taken for testing from this mohalla have been tested negative for COVID-19. Therefore in view of the same, Containment of this area is not required to be continued as such.

NOW THEREFORE, keeping in view the facts as mentioned above, order no. CBA/SDM/READER/COVID-19/2020: 3160-71 dated 07.09.2020 issued by this office earlier is hereby ordered to be withdrawn.

However, these de-sealing orders shall not be applicable to the residential buildings/shopping complex/shops of the persons or related to the persons who have been tested positive for COVID-19. The persons concerned shall remain home quarantined for the period as prescribed by the MoH, Govt. of India as well as Govt. of Himachal Pradesh. The Executive Officer, Municipal Council Chamba and the Ward Member of Municipal Ward concerned shall ensure that the persons tested positive are not roaming here and there in the area and abiding home quarantine protocol strictly.

It is further ordered that the area as mentioned above shall no longer be sealed and is hereby de-notified as Containment Zone. All curfew relaxations notified by the District Magistrate Chamba vide his office's orders circulated from time to time shall now be applicable in this area also.

This order shall come into force with immediate effect.
