

**Office Order**

Keeping in view of the danger spreading of Corona Virus (COVID-19), due to five persons of Sub Tehsil Kakira of Sub Division Bhattiyat have been found positive for COVID-19.

Whereas, I am convinced that for preventing danger to human life, health and safety and to contain the spread of COVID-19, it is required to notify a Containment Zone and Buffer Zone as per guidelines issued by Ministry of Health and Family Welfare, in the affected area, as recommended by Naib Tehsildar Kakira vide letter dated 30<sup>th</sup> November 2020.

Now therefore, I Bacchan Singh IAS, Sub Divisional Magistrate Bhattiyat in exercise of the power vested in me vide order No. CBA-DA-2(31)/2020-18365-79 dated 14<sup>th</sup> July 2020, issued by Worthy District Magistrate Chamba Distt. Chamba HP do hereby order complete restriction on any movement inside or outside of Containment Zone as notified in this order. It is further ordered that:

1. No person shall leave their homes or move on foot or by vehicle or roam around or stand on any road or public place in the villages which are notified as Containment Zone Sub Tehsil Kakira as mentioned below:-

2. Any assembly of four or more people shall also stand banned in the above area.
3. All shops/commercial establishments shall remain closed, except for Govt. medical facilities and authorized essential supply outlets till further orders.
4. This order shall not apply on Officer on Magistrate duty, police personnel, Officers involved enforcement of these orders, those engaged in emergency/Health care duty and those specially permitted by the undersigned or Executive Magistrate of the concerned area. The major road lying in containment zone shall remain through for movement of vehicular traffic, however, no vehicle shall be allowed to board or deboard passengers in area contained.

Since this is a case of extreme emergency and the circumstances are such that serving of this order is not practicable and possible upon persons in jurisdiction of the aforementioned area of the Sub Division Bhattiyat and therefore, it is necessary and expedient to proceed ex-parte under section 144 of the Code of Criminal Procedure, 1973.

Any violation of the order shall be liable for action and section 188 of IPC and the violator may also be prosecuted under the relevant section of IPC and other provision of law in this respect.
