ORDER

WHEREAS, it has been brought to my notice by the Block Medical Officer Salooni, that numerous persons resident of village **Manjeer of Gram Panchayat Manjeer, Sub Division Salooni** have been detected COVID-19 positive during sampling. To contain and stop the spread of COVID-19, the undersigned has declared entire **Village Manjeer (including area of Manjeer Market)** as Containment Zone with effect from **14 December 2020 to 19 December 2020**.

Whereas, I am convinced that for preventing danger to human life, health and safety to contained the spread of COVID-19, it is necessary to declare **village Manjeer (including area of Manjeer Market) of Gram Panchayat Manjeer** of Sub Division Salooni as containment zone wherein the movement and public interaction of the person referred above may have occurred.

WHEREAS, it is the case of extreme emergency and the circumstances are such that serving of notice upon persons residing in the jurisdiction of aforementioned areas of Sub-Division is not practicable and possible therefore, it is necessary and expedient to proceed ex-parte under Section 144 of the Code of Criminal Procedure, 1973.

NOW THEREFORE, I, **Kiran Bhadana, IAS, Sub Divisional Magistrate, Salooni** in exercise of the power vested in me vide letter No. CBA-DA-2(31)/2020-18365-79 dated 14th of July 2020, from District Magistrate Chamba, Distt. Chamba HP and under section 144(1) of Criminal Procedure Code 1978, do hereby order complete restriction at **village Manjeer (including area of Manjeer Market) of Gram Panchayat Manjeer** from **14 of December 2020 to 19 of December 2020** on any movement inside or outside of Containment Zone as notified in this order. It is further ordered that:-

1. No person shall leave their homes or move on foot, or by vehicle or travel or roam around or stand on any road or public place in above said village which is notified as Containment Zone.
2. Any assembly of 4 or more shall also stand banned in the above areas.
3. All shops/ commercial establishment/Banks shall remain closed, except for government medical facilities and authorized essential supply outlets for home deliveries till further orders.



4. This order shall not apply on officers on magisterial duty, police personnel and those engaged in emergency/health care duties and those specially permitted by the undersigned.

Any violation of the order shall be liable for action under Section 188 of IPC and the violator may also be prosecuted under the relevant sections of IPC and other provisions of law in this respect.
