



**ORDER**

In continuation of State Executive Committee's Orders No. Rev (DMC)(C)20- 2/2020- COVID-19 dated 28<sup>th</sup> November and 15<sup>th</sup> December 2020, and in exercise of the powers conferred under the Section 24 (c) of the DM Act 2005, the undersigned in capacity of the Chairman, State Executive Committee (SEC), hereby orders the following amendments in the Orders and directs all the Departments & Organisations of the Government, District Magistrates, Police Officers/Officials and Local Authorities of the State to ensure strict implementation of the directions:

**Following directions stand amended:**

- 1) Henceforth, duration of Night Curfew in district Mandi, Shimla, Kullu and Kangra will be from 10.00 PM to 6.00 AM. There shall be no movement of persons and vehicles except those involved in the maintenance/delivery of essential/emergency goods & services or in case of medical emergency during these hours for the period mentioned above. Respective District Magistrate will issue orders in this regard.
- 2) The directions regarding weekly closing day for markets/shops in the State stand withdrawn with immediate effect.
