ORDER


Whereas, an order No. Rev (DMC) (C) 20-2/2020-COVID-19 dated 31st December, 2020 was issued by the SEC to contain the spread of COVID-19 pandemic in Himachal Pradesh and in compliance of the same order District Administration Chamba has also issued the order No. CBA-Relief-3(36)/2019-01-98 dated 01.01.2021 to contain the spread of COVID-19 in the District;

Whereas, in continuation of above referred order of SEC the State Government of Himachal Pradesh has incorporated few amendments vide order No. Rev. (DMC) (C) 20-2/2020-COVID-1- dated 5th January 2021 and directed to District authorities & others for its implementation;

And therefore, I Duni Chand Rana (IAS) District Magistrate Chamba in compliance of above said order of SEC/DMC do hereby order the following amendments in this office order No. CBA-Relief-3(36)/2019-01-98 dated 01.01.2021: -

1. That there shall be no restrictions regarding seating capacity in Inter-State as well as Intra State buses. However, all COVID-19 related safety protocols shall be followed. The RM (HRTC) Chamba and RTO Chamba shall ensure the compliance of SOPs issued by the Department of Transportation in this regard;
2. That the restrictions regarding gatherings etc. will not be applicable in regard to conduct of election related trainings subject to adherence to the SOPs issued by State Election Commission or issued by this office;
3. That All private/government institutions/centers imparting coaching for the competitive examinations shall function at 50% capacity subject to adherence to the SOPs issued by Education Department.
