ORDER

Whereas, the Union Home Secretary-cum-Chairman, National Executive Committee (NEC) under Disaster Management Act 2005 has issued the direction vide order No 40-6/2020-DM-I(A) dated 25th April, 2021 for making available all production of liquid oxygen to the Government for use for medical purposes.

Whereas, the cases of COVID-19 have been increasing in the District at a rapid pace and there is a need to setup additional facilities and strengthen the existing facilities for treatment of patients in District and there is an urgent need for oxygen availability for proper functioning of these medical facilities.


Therefore I, D C Rana, IAS, District Magistrate Chamba, in exercise of the powers vested in me under Section 34 of the Disaster Management Act 2005 do hereby order that all private persons, organizations, industries and establishments shall deposit the B and D type Oxygen cylinders available with them at HRTC Training Centre at Tadoli, Chamba for utilization in medical facilities created for COVID-19 patients in District Chamba, with immediate effect.

It is further ordered that GM-DIC, Chamba Sh. Chander Bhushan shall be the Nodal Officer for managing this facility and he shall ensure the collection of all D and B type cylinders available with aforementioned organizations at the Centre, for further usage in medical facilities. The private agencies can contact the Nodal Officer at 98059-55648 for further liaisoning.

Further, the committee notified at point 7 vide order No. CBA-Relief-3(36)-2020-1321/1429 dated 26th April, 2021 shall supervise the collection, filling and distribution of these oxygen cylinders so collected for further usage in medical facilities.

This order shall be applicable with immediate effect and shall remain in force till further orders. Any violators shall be proceeded against as per the provisions of Sections 51-60 of Disaster Management Act, 2005 besides legal action under section 111, 114 & 115 of HP Police Act, 2007, section 188 of IPC, and under relevant provisions of Himachal Pradesh Epidemic, Disease (COVID-19) (Amendment) regulations 2020 and other legal provision as applicable.
