**ORDER**

Whereas, the Block Medical Officer, Health Block Pukhri and Block Development Officer, Development Block Chamba have brought to my knowledge that 5 (Five) COVID-19 positive cases have been detected in a single building/house in village Naghuine of Gram Panchayat Dradha and 7 (Seven) COVID-19 positive cases have been detected in village Kotla, Ward no. 5-Bhagwanpura of Gram Panchayat Sarol today on 02.05.2021. It has further been informed that there is an apprehension that these areas may become a probable HOTSPOT of COVID-19, unless strict measures are not taken urgently for its geographic quarantine. Consequent upon the finding of COVID-19 positive cases and further containing its spread, the areas as mentioned in the table below has been recommended to be declared as Micro Containment Zone (s).

Whereas, I am convinced that for preventing danger to human life, health and safety of the general public and to contain spread of COVID-19 disease further, it is necessary to declare areas of Gram Panchayat Dradha and Sarol as Micro Containment Zone (s), wherein the movement and public interaction of the persons tested positive for COVID-19 may occurred.

Whereas, it is a case of extreme emergency and the circumstances are such that serving of notice upon all persons residing in the jurisdiction of the area as mentioned below is not practicable and possible and therefore, it is necessary and expedient to proceed ex-parte under Section 144 Cr.PC of the Code of Criminal Procedure, 1973.

Therefore, in view of the above circumstances and as an emergency containment measures, **I, Shivam Pratap Singh, IAS, Sub Divisional Magistrate Chamba**, Distt. Chamba, Himachal Pradesh, in exercise of the powers vested in me under section 144 of the Code of Criminal Procedure, 1973 and subsequent powers delegated to the undersigned by the District Magistrate Chamba, Distt. Chamba, H.P. vide his office's order no. CBA-DA-2(31)/2020: 18365-79 dated 14.07.2020, do hereby order and direct the COMPLETE SEALING OF THE AREA OF THE CONTAINMENT ZONE (s) as shown below;

**It is further ordered and directed that;**

- (i). The abovementioned areas of Gram Panchayats **Dradha and Sarol** as recommended to be declared as Containment Zone (s) is hereby ordered to be Cordoned Off. No person residing in these areas shall be allowed to assemble, gather or congregate. They shall remain inside their houses except in case of emergency.
- (ii). The areas mentioned in column no. 4 of the table above, is hereby ordered to be declared as Buffer Zone (s).
- (iii). No person shall participate; organize any function (s) demonstration (s) meeting(s) procession(s), rally, picketing, workshop(s), community or religious events within the limits of the containment zone mentioned above.
- (iv). The shops if any shall remain closed except Chemist Shop(s).
- (v). The govt. offices if any, providing essential services shall remain open subject to the conditions that social distancing norms and other instructions/guidelines as prescribed by the government shall be followed in true letter and spirit.
- (vi). All persons engaged in providing essential services and residing in those areas except the member of Covid-19 positive cases shall attend their duties and shall take all necessary precautions.
- (vii). All essential commodities shall be supplied door-to-door inside the containment area for the convenience of the general public by the Pradhans/Up-Pradhans of Gram Panchayats concerned. The Distt. Food &

Supplies Controller Chamba through Depot Holder of these areas shall render them every possible help during the containment period. Un-interrupted supply of drinking water and electricity shall be ensured by the departments concerned.

- (viii) Sanitization in containment areas shall be carried out by the Gram Panchayat concerned on regular basis.
- (ix) The Block Medical Officer, Health Block Pukhri shall ensure to keep the medical team(s) constituted/stationed for the areas round the clock to keep strict vigil on the health of the people.
- (x) The Station House Officer, Police Station Sadar Chamba shall ensure to keep a strict vigil on the enforcement of containment order in the aforementioned area.
- (xi) The Drug Inspector Chamba shall ensure regular supply of necessary medicines to the people residing in the abovementioned areas through local Chemist Shops.
- (xii) The Naib Tehsildar Chamba shall perform duties as **DUTY MAGISTRATE** for the containment areas. He shall ensure proper implementation of this order and supply of essential commodities to the people residing inside the abovementioned areas.
- (xiii) This order shall not apply on officer on Magisterial duty, Police Personnel (s) Officers/Official involved in enforcement of these orders and other authorized person(s)/vehicle(s) engaged in supplying of essential commodities and health services.

Any person contravening this order shall be liable for action under Section 269, 270 and 188 of Indian Penal Code, 1860 as well as other legal provisions as applicable in this respect.

This order shall come into effect immediately and shall remain in force till further orders.
