**ORDER**

It is to inform you that a large number of migrated shepherds have started returning to the District. However, in view of the COVID-19 epidemic, it is necessary that, their movement is strictly monitored to contain the threat of COVID-19.

The following directions are therefore, issued for this purpose.

1. The Deputy Director Animal Husbandry shall share details of all shepherds registering of shepherd Inspector at the Veterinary Check post established in the District with this Office Control room at [ddmachamba@gmail.com](mailto:ddmachamba@gmail.com) and respective SDMs.
2. That a medical team shall be present at veterinary check post to screen the incoming shepherds and any person found with Influenza-like illness (ILI) shall be tested for COVID-19 through RAT and will be dealt as per protocol described.
3. The respective SDMs shall ensue regular follow-up of the shepherds entering their area through field functionaries to keep a check on their health status. The BDOs shall ensure to prepare a list of such shepherds through the PRIs and ensure sharing of the same with the SDM control room. A medical check-up shall also be carried out regularly after every 7 days and regular basis.
4. It is possible that some shepherds may enter the District by passing the veterinary check post. For this SDMs shall ensure that all PRIs and Panchayat Officers maintain strict vigil for any such person entering their panchayat and immediately inform the SDMs/BDOs so that these persons can also be included in the monitoring framework. The PRIs and

Panchayat Secretaries shall be duty bound to keep a lookout & inform of every such instance to SDMs & BDOs.

The above Order is issued under section 3 Himachal Pradesh Epidemic Diseases (COVID-19) (Amendment) Regulations, 2020 and any contravention or violation shall be liable for action under provision of aforementioned Regulation.


