**ORDER**

**WHEREAS**, Himachal Pradesh Disaster Management Authority (HPSDMA), has considered the unprecedented surge in COVID-19 cases, high positivity rate and fatalities in the State from time to time, and in order to break the transmission chain of COVID-19 virus, has imposed certain restrictions in the State of Himachal Pradesh which was last extended vide order dated 22.07.2021 which is in effect till further orders with some restriction and relaxations as an emergency measures and in compliance of said order this office had issued order dated 23<sup>rd</sup> July, 2021 and 7<sup>th</sup> August, 2021 for containment of COVID-19 in District Chamba ;

**AND WHEREAS**, in continuation to this office order No. CBA-Relief-3(36)/2021-21280-430 dated 11<sup>th</sup> August, 2021 and in compliance of order/directions issued by the State Executive Committee (SEC) vide orders No. Rev (DMC) (C) 20-2/2021-COVID-19 dated 20<sup>th</sup> August, 2021, the undersigned in the capacity of Chairman DDMA Chamba in exercise of the power vested in me under section 34 of the Disaster Management Act, 2005 it is further order that;

1. All schools shall continue to remain close, except residential schools further up to 28<sup>th</sup> August, 2021. Teaching and non-teaching staff shall continue to attend the school. For residential schools, SOPs developed by the department of Education will be followed to contain the spread of COVID-19.

The compliance of this order shall be ensured by the Senior Superintendent of Police, Chamba, all the Sub-Divisional Magistrates, all the Head of Departments, Executive Magistrates, the Deputy Director Higher/ Elementary Education, Chamba, District Chamba.



Any person violating these measures and COVID-19 appropriate will be liable to be proceeded against as per the provisions of sections 51-60 of the Disaster Management Act, 2005 besides legal action under Section 188 of IPC and other legal provisions as applicable.

**This order shall come into force with immediate effect in the entire territorial jurisdiction of Chamba District and shall remain valid till further orders.**

**ORDER**

Taking note of the present situation of COVID-19 active cases and positivity rate in the State, the undersigned in the capacity of the Chairman-State Executive Committee (SEC), in exercise of the powers conferred under Section 22(2)(h) and Section 24 of the Disaster Management Act 2005, and in continuation of earlier SEC orders, hereby directs that:

1. All schools shall continue to remain close, except residential schools further up to 28.08.2021. Teaching and non-teaching staff shall continue to attend the school. For residential schools, SOPs developed by the Department of Education will be followed to contain the spread of COVID-19.

**Penal Provisions:**

Any person violating these measures and not following COVID appropriate behavior will be liable to be proceeded against as per the provision of Section 51-60 of the Disaster Management Act, 2005, besides entailing legal action under Section 188 of the IPC, and other legal provisions as applicable.

**This order will come into effect immediately and shall remain in force till further orders.**
