ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Whereas, the Sr. Superintendent of Police Chamba vide his communication No. Sec/21-48876 dated 27.08.2021 has intimated that in view of increasing strength of outsider labourers, tenants/ domestic servants in the district and a two explosions reported recently at Air Force Station in Jammu Air Port in which the first drone strike at an Indian Base was witnessed and 2<sup>nd</sup> Blast at Jammu Air Port on 27.06.2021, there is possibility of anti national element/militants might try to infiltrate/intrude in to the territory of district Chamba;

And whereas, it is suggested by the Sr. Superintendent of Police Chamba that it is necessary to put a check on the anti social elements/ persons engaged in spreading communal disharmony. The antecedents of people coming from outside of this State, who are engaged in cloth/shawl selling, repair of metal implements cleaning/utensils, migrant labourers engaged by contractors/company in Electric Hydro Power Projects and other private sectors need to be verified and requested to invoke the provisions of section 144 Cr.PC;

Therefore, I, D C Rana, IAS, District Magistrate, Chamba District Chamba am of the considered opinion that the antecedents of people coming from outside of this state as mentioned in para supra are required to be verified and imposition of Section 144 Cr. PC is warranted in the Chamba District to avoid any such kind of untoward incident in the District. I, therefore, do hereby invoke the

provisions of section 144 Cr. PC in District Chamba for a period of 60 days from the issuance of this order in public interest and it is directed that:

1. No employer/ contractor/trader shall engage any Migrant Labourer visiting Chamba District in petty non-formal job or services or contract labour unless and until such migrant labourer has furnished his particulars along with a photograph of pass port size to the Station House Officer concerned for identification and verification of his antecedent.
2. No person as stated supra visiting Chamba District shall engage himself in any kind of self-employment or seek employment in non-formal trades or service without informing his intention to this effect to the Station House Officer under whose jurisdiction he intends to seek such employment or engage in self-employment.
3. In addition to above, all the SDMs of District Chamba, particularly Tissa, Chamba and Salooni are directed to keep a sharp vigil over such persons who are engaging in any activity as stated supra and review the same regularly.
4. All the religious institutions/places of worship and complexes thereof housing such persons shall keep complete record of such persons and shall not allow any person to stay in such institutions till they have been registered with the Station House Officer of Police concerned.

In view of the emergent nature of the order, it is being issued ex-parte and is addressed to the public in general.

The order shall come into force with effect from zero hours on 02-09-2021 and shall be effective for a period of 60 days i.e. up to 01-11-2021.



Any breach of this order shall make such migrant labourer and his employer or person giving shelter liable for penal action U/S 188, the Indian Penal Code.
