കോട്ടയം നഗരത്തിൽ ഏറ്റവും തിരക്ക് അനുഭവപ്പെടുന്ന ജംഗ്ഷനുകളിൽ ഒന്നായ കഞ്ഞിക്കുഴിയിലെ ഗതാഗതക്കുരുക്ക് കുറയ്ക്കുന്നതിലേയ്ക്കായി ബഹു. ജില്ലാ പോലീസ് മേധാവി 5 ഇന നിർദ്ദേശങ്ങൾ സമർപ്പിച്ചിരിക്കുന്നു.

2.ഇപ്രകാരം പോകേ വാഹനങ്ങൾ മദർ തെരേസ റോഡ് വഴി റബ്ബർ ബോർഡ് ജംഗ്ഷനിൽ എത്തി പോലീസ് ക്ലബ്ബ് - ഈസ്റ്റ് പോലീസ് സ്റ്റേഷൻ ജംഗ്ഷൻ വഴി കെ.കെ. റോഡിൽ പ്രവേശിച്ച് യാത്ര തുടരുക. എന്നാൽ ഇറഞ്ഞാൽ ഭാഗത്തുനിന്നും കെ.കെ. റോഡ് വഴി പോകേ വാഹനങ്ങൾക്ക് ഫ്രീ ലെഫ്റ്റ് സ്വീകരിച്ച് യാത്ര തുടരാവുന്നതാണ്.
