In exercise of the powers conferred by 2nd proviso of subsection 7 of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), the Government of Kerala hereby extent the time limit in publishing the declaration as per sub-section 1 of section 19 to the Notification issued under sub- section (1) of section 11 as per G2- 45522/14 dated 07th February, 2019 and published in the Kerala Gazette Extraordinary No 317 dated 11th February 2019, namely:-



Extension

Notification No G2-45522/14 dated 07th February, 2019 has been issued in accordance with the provisions of sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 with regard to the acquisition of 14.99 ares of land in Athirampuzha Village for the improvements of Athirampuzha Town in Kottayam district.

AND Whereas, the District Collector, Kottayam has reported that as per Section 19(2) specifies that the Requisitioning Authority shall deposit the entire amount under the relevant head for publishing 19(1) Declaration and as such they had requested the Requisitioning Authority for depositing the entire amount on 13.12.19 with regard to the acquisition of 14.99 ares of land in Athirampuzha Village for the improvements of Athirampuzha Town in Kottayam district and the same has not been released so far. It has also been reported that as per Section 19(7) of LARR Act, 2013 mentions that the 19(1) Declaration has to be published within 12 months from the date of issuance of 11(1) Notification (preliminary notification) and that the 11(1) Notification issued as per No G2-45522/14 dated 07th February, 2019 will expire by 06.02.2020 hence requested to extent the time limit for a further period of 3 months from 06.02.2020 for publishing the 19(1) Declaration.

Now THEREFORE, sanction is accorded to extend the time limit in publishing the declaration for a further period of 3 months from the date of expiry of 11(1) Notification ie, 06.02.2020 by invoking the provisions contained in 2nd proviso to Section 19(7) of the LARR Act, 2013 so as to enable the District Collector, Kottayam to declare Rehabilitation & Resettlement package & deposit the entire amount for compensation under the relevant head as per Section 19(2) of LARR Act, 2013 with regard to the acquisition of 14.99 ares of land in Athirampuzha Village for the improvements of Athirampuzha Town in Kottayam district.
