## NOTIFICATION

**F.No. 2/4/2014-TD/45 :-** In exercise of the powers conferred by the Government of India, Ministry of Home Affairs Notification No. 2/7/63-LMA dated 4<sup>th</sup> February, 1963, and OM No. AB-14017/48/2010-Estt-(RR) dated 31-12-2010 of the Government of India, Department of Personal and Training and in supersession of the Orders relating to the Recruitment Rules, the Administrator, Union Territory of Lakshadweep hereby makes the following rules to amend the Recruitment Rule to Group-B posts (Non Gazetted) Non Ministerial under Tourism Department of Lakshadweep Administration issued in Notification F.No. 3/2/2011 TD (2), dated 04-06-2011.

**1. Short Title and Commencement :-** (i) These Rules may be called the Lakshadweep Tourism Department Group- 'B' Non-Gazetted, Non-Ministerial Recruitment (3<sup>rd</sup> Amendment) Rule, 2016 for the recruitment of Tourism Officer.

(ii). They shall come into force on the date of their Publication in the Official Gazette.

**2. Number of posts, Classification and Scale of Pay :-** The number of posts, and their classification and Scale of Pay attached thereto shall be as specified in Sl. No. 2 to 4 of the schedule annexed to these rules.

**3. Method of Recruitment, Age Limit, other Qualifications etc :-** The method of recruitment to the said post, age limit, qualifications and other matters relating thereto shall be as specified in Sl. No. 5 to 13 of the aforesaid Schedule.

**4. Disqualification :-** No person

(i) who has entered into or contracted a marriage with person having spouse living  
**OR**

(b) who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and that there are grounds for so doing, exempt any person from the operation of the rules.

**5. Power to Relax:-** Where the Administrator, Union Territory of Lakshadweep, is of the opinion that it is necessary or expedient to do so, he may, by order for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons except rule 4 of these Rules.

**6. Savings :-** Nothing in these Rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

This issues with the approval of Hon'ble Administrator vide Diary No. 4546, dated 18-11-2016.

Graduation in any field with 2 year Post Graduation/PG Diploma in Tourism/Travel/Hospitality/Hotel Management from a Government recognized Institute.\*
08. Whether age and educational qualification prescribed for direct recruits will apply in the case of promotees. : NA.
09. Period of probation : 2 years.
10. Method of recruitment whether by direct recruitment or by promotion transfer and percentage of vacancies to be filled by various methods. : Direct recruitment failing which by transfer on deputation.  
**Note :** 'Vacancies caused by the incumbent being away on deputation or long illness or study leave or under other circumstances for a duration of one year or more may be filled on deputation basis from officers of Central Government/State Government/Union Territory Government.
11. In case of recruitment by promotion/ deputation/ transfer, grades from which promotion to be made : Transfer on deputation from employees working in Central Government /State Government Union Territory Administration and  
(i) holding analogous posts on regular basis or  
(ii) 6 years regular service in the Pay Band ₹ 29200 (Revised Pay, 2016)  
“(The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed five years)”.

12. If a DPC exists what is its composition : 1. Secretary (Tourism) - Chairman  
: 2. Director (Tourism) - Member  
: 3. Director (Services) - Member  
: 4. One member from ST Community - Member.
13. Circumstances in which UPSC is to be consulted for making recruitment. : NA.

\* With respect to Tourism/Travel/Hospitality/Hotel Management subjects, the written examination will have syllabus of Graduation level only and not of Post Graduation level.
