NOTIFICATION

F.No. 12/55/2002-Services. Vol.II/3724 :- In pursuance of the directions of the Hon'ble Supreme Court of India vide order dated 31-10-2013 in the Writ Petition (Civil) No. 82 of 2011 (under Article 32 of the Constitution of India) read with Office Memorandum F.No. 14040/22/2013-UTS.I dated 31-12-2013 of the Government of India, Ministry of Home Affairs, New Delhi, the Administrator, Union Territory of Lakshadweep is pleased to constitute the Civil Service Board in respect of the All India Services, DANICS/DANIPS Officers and Head of Departments working under Union Territory of Lakshadweep with immediate effect, in the following manner:-

I. The Composition of Civil Service Board, Lakshadweep will be as follows:-

The Board may co-opt the Secretary (Home) while making transfer and posting of IPS and DANIPS Officers and Secretary (Environment and Forest) while making transfer and posting of IFS Officers.

II. Functions :-

The Civil Service Board shall make recommendations to the Government of India on the following service matters :-

(a) Transfer and Posting of All India Services Officers, DANICS Officers, DANIPS Officers and Head of Department under Lakshadweep Administrations.

(b) While making recommendations, the requirement of the minimum tenure of service as prescribed by the Government shall be kept in view by the Board.

(c) The Civil Service Board may consider transfer of Officers before the tenure based on the necessity and circumstances which the Civil Service Board shall satisfy itself.

(d) The Civil Service Board may recommend the names of Officers to the Competent Authority for transfer before completion of minimum tenure with reasons to be recorded in writing.

III. Procedure :-

(a) The proposals for transfer and posting of DANICS, DANIPS and Head of Department shall be referred to the Board by the Secretaries of the concerned Departments.

(b) The Civil Service Board shall :-

(i) Consider the report of the Secretary of the concerned Department along with any other inputs it may have from other reliable sources.

(ii) The Board may have the option to obtain the comments or views of the Officer proposed to be transferred regarding the circumstance presented to it in justifications of the proposal.

(iii) The Board shall satisfy itself regarding the inevitability of the premature transfer before making a recommendation to the Government based on clear findings.

(c) The Competent Authority may over-rule the recommendation of the Civil Service Board, by recording reasons in writings.
