NOTIFICATION

F.No. 2/1/2012-DOP :- The Administrator, Union Territory of Lakshadweep vide Notification F.No. 2/1/2012-DOP dated 07-03-2012 had devolved functions, functionaries and funds to the District Panchayat, Lakshadweep. As per the Notification all the continuing or new schemes under the Education Sector up to Higher Secondary level including centrally sponsored schemes are devolved to the District Panchayat.

The Executive Committee, Lakshadweep Sarva Shiksha Abhayan, State Mission Authority, in its meeting held on 24-10-2016 has decided to designate Director of Education as the Ex-Officio State Project Director of Sarva Shiksha Abhayan as directed by the Technical Support Group of Ministry of Human Resource Development. He shall be the Controlling Authority of all staff under Sarva Shiksha Abhayan. The Director of Education shall also be the State Mission Director of Rashtriya Madhyamik Shiksha Abhayan for the smooth functioning of the Centrally Sponsored Scheme.

Based on the above decisions the Schemes Sarva Shiksha Abhayan and Rashtriya Madhyamik Shiksha Abhayan are transferred to the Directorate of Education with immediate effect.

These orders shall come in to force from 1st November, 2016.
