14 of Indian cities figure in World's20 most polluted cities list: WHO

New Delhi: Delhi and Varanasi are among the 14 Indian cities that figure in a list of world's 20 most polluted cities in terms of particulate matter PM2.5 levels in 2016. PM2.5 includes pollutants like sulfate, nitrate and black carbon, which pose the greatest risk to human health. According to data released by the World Health Organisation (WHO), other Indian cities that registered very high levels of PM2.5 pollutants were Kanpur, Faridabad, Gaya, Patna, Agra, Muzaffarpur, Srinagar, Gurgaon, Jaipur, Patiala and Jodhpur. They were followed by Ali Subah AlSalem in Kuwait and a few cities in China and Mongolia.

The data also said, nine out of 10 people in the world breathe air containing high levels of pollutants.

In terms of PM10 levels, 13 cities in India figured among the 20 mostpolluted cities. WHO has called upon membercountries in its Southeast Asia Region to aggressively address the double burden of household and outdoor air pollution. It said, the region accounts for 2.4 million of the seven million premature deaths caused by household and outdoor air pollution together globally every year.

Aadhaar not mandatory for mobile SIM, says government

New Delhi : The government on Wednesday stated that Aadhaar is not mandatory for getting a SIM and that a phone number can be issued using alternative identification cards such as voter ID or driving licence. "Mobile companies have been asked to follow the instructions immediately so that consumers are inconvenienced," Telecom Secretary Aruna Sundararajan said.

Government releases draft new telecom policy aimed at creating 40 lakh new jobs by 2022

New Delhi : Government has released the draft of the new Telecom policy-National Digital Communications Policy, 2018. The policy aims at creating 40 lakh new jobs by 2022, attracting 100 billion US dollars investment in the sector and ensuring broadband coverage at 50 mbps for every citizen.

The draft proposes one Gbps connectivity to all Gram Panchayats by 2020 and $10~\mathrm{Gbps}$ by 2022. It also proposes to address woes of the Telecom sector by reviewing licence fees, spectrum usage charges, universal service obligation fund levy for enhancing ease of doing business in the

The policy also aims to enhance the contribution of digital communications space to 8 per cent of the country's GDP from about 6 per cent last year. It recognises the importance of continued improvement in the regulatory framework for attracting investments ensuring fair competition, to serve the needs of the people.

PM Modi emphasises need to use technology in celebrations of 150th birth anniversary of Mahatma Gandhi

New Delhi: Prime Minister Modi Narendra has emphasised the need to use technology in celebrations of the 150th birth anniversary of Mahatma Gandhi so that the whole world can take note and participate.

Mr Modi said this at the first meeting of a national committee set up plan events commemorate the birth anniversary of Mahatma Gandhi.

President Ram Nath Kovind yesterday chaired the meeting in New Delhi. Prime Minister called for the celebrations to move

beyond government events and take the shape of a mass movement or Jan Bhagidaari. Mr Modi also urged all state governments to have similar consultations and draw plans at the state

The Prime Minister stressed that all programmes associated with celebration should be designed around the theme of Karyanjali or Gandhi in action. He expressed happiness that suggestions received during the meeting were mostly action-oriented. Mr Modi said, Mahatma Gandhi and his teachings are timeless.

Indian and Malaysian armies begin **Exercise** Harimau Shakti 2018 in Kuala Lumpur

New Delhi: The troops of the Indian and Malaysian kick-started armies 'Exercise Harimau Shakti 2018' in Kuala Lumpur yesterday.

A statement by the Indian Army said this is the first-ever joint Army exercise between the armies of India and Malaysia.

The first phase of the two-week long exercise began with the formal handing over of the Regimental Flag to the Malaysian Army, signifying merging of the two contingents under one commander.

Both armies stand to hone their tactical and technical skills in counterinsurgency and counterterrorism operations under the UN mandate.

Due emphasis will be laid on increasing interoperability between forces which is crucial to the success of any joint operation.

- 3. Travel Card number will eliminate duplicate applications for a particular route on a particular voyage, thereby enabling greater availability of tickets.
- Those who don't possess Ration Card and therefore cannot generate Travel Card, can use their Aadhar number instead.
- Travel Card number or Aadhar number will be made mandatory field for booking of ship tickets.

Govet launches Pilot Scheme for procurement of aggregate power of 2500 MW on competitive basis for 3 years

New Delhi: Government has launched a Pilot Scheme for procurement of aggregate power of 2500 MW on competitive basis for three years under medium term from commissioned power plants without power purchase agreements. The bids under the scheme will be invited in the first week of May.

The main purpose of the scheme is to revive commissioned power plants which are unable to sell electricity in the absence of

valid power purchase agreements. These plants can bid for power supply under the scheme.

Under the scheme a single entity can be allotted maximum capacity of 600 MW. The Scheme assures a minimum off-take of 55 per cent of contracted capacity. The Tariff will be fixed for three years without any escalation.

The Ministry of Power had recently issued the model bid documents, model PAPP and PPSA on 6th of this month. The guidelines for the scheme were issued on 10th of this month.

PFC Consulting Limited, a fully owned subsidiary of PFC Ltd, has been appointed as Nodal Agency and PTC India Limited as the Aggregator. PTC India would sign threeyear, Agreement for Procurement of Power with successful bidders and Power Supply Agreement with the Discoms.
