
Sub: Announcement for Haj-1440 (H) - 2019.

As per the information from Haj Committee of India (HCOI), the process of application for Haj-2019 through Haj Committee of India shall commence from 18.10.2018. The prospective pilgrims are directed to fill the Haj application in online visiting the HCOI website [www.hajcommittee.gov.in](http://www.hajcommittee.gov.in). Hard copies of online Haj application Form along with all requisite documents shall be accepted in the office of respective DC/SDO's of all concerned Island from 18.10.2018 to till 17.11.2018 during working hours and applicants belongs to Kavaratti are directed to submit hardcopies directly to Haj Cell, Kavaratti.

Applicant must read the Guidelines carefully and select their Category of Accommodation in Makkah & Madinah, and Adahi (Qurbani) as per their convenience. Option once selected will not be allowed to change. The Applicant must be in possession of machine readable valid Indian International Passport issued on or before 17.11.2018 and valid up to 31.01.2020. Therefore, all DC/SDO's of concerned Islands are requested to give wide publicity for the information of intending pilgrims of Haj-2019.

**New features of HAF-2019**

1. The Cover Strength is five (5) adults i.e maximum 5 adults and 2 infants.
2. Embarkation point : Pilgrims from Lakshadweep are to be selected "KOCHI" as their Embarkation point.
3. Adhar Card/ Enrolment No. and Pan No. may be given.
4. Accommodation in Makkah : Azizya Category (Accommodation in Azizya area) and NCTZ (accommodation from 1 km of Haram Shareif)
5. Accommodation in Madinah : Within Makazia area (Within 500 meters from Haram Shareif) and Outside Markazia area (Within 1000 meters from Haram Shareif)
